3. CDC Curriculum Proposals

Take 2 on Music:

11-543: HSU Program Change MUISIC EDUCATION

After an "over-haul" of the Music Education Major curriculum, several changes are proposed for the major and are summarized below. The total major unit requirements change from 71 units to 74 units. Of the 60 GE University requirements 12 are double counted, adding up to 48. This brings the total to 122. The only way for this to not exceed the 120 maximum is for students to double count one Institutions as Area D and double count a GE course with the domestic DCG. This reduces the total by 6, giving 116 total units for the major.

Revision: In response to the Provost's decree that no units may be added to a major, the program will drop two semesters of studio lessons for next year. In addition, the department commits that by the March curriculum deadline, the program will submit a proposal for a revised Music Education major that has no more units than the 2011/12 version of the major.

11-421: HSU Program Change

SPAN 106 (Spanish Level II) is proposed to be included as a requirement for the Spanish Minor. Currently the minor program has 28 units, addition of SPAN 106 to the minor program would increase by 4 units; however, the minor electives will be reduced from 9 to 5. Thus, the same 28-unit requirement will be maintained. The Spanish department feels this change will encourage earlier consideration for this minor option during student academic planning.

11-567: HSU Program Change

Pending approval of the large Music Education Program Change (11-544 through 11-549) MUS 355: Intermediate Voice will be eliminated. This course is not a requirement for the Music Studies Option; however, is mentioned as a possible substitute for studio lessons. This proposal will eliminate the mention of 355 as a substitute for studio lessons.

Action: Recommend Approval pending the decision for 11-544 through 11-549 (Chris)

12-136: HSU Course Change Form

The Math department wishes to change the classification of MATH 99: Supplemental Instruction in Remedial Math from 2 units of C14 to 2 units of C5. They site the 1:1 correspondence between WTUs and student contact hours are more appropriate.

Action: Uncertain, could use some discussion. (Chris)

12-060: HSU New Course Proposal

A new course, GEOG 356: Global Ecology and Biogeography (3 units, C2), is proposed as an additional option for Geography majors. Addition of this course does not change the program (i.e. no additional units are required). The content of this course has been taught previously as a special topics course (GEOG 473) and was well enrolled (Fall 2009: 24 students, Spring 2011: 32 students). The course will be offered once every other year; however, there is no indication if this will be Fall or Spring. The course perquisite is GEOG 106 and the course is intended for junior/senior standing Geography students. There will be an academic restriction for freshman and sophomore standing students. Rosemary Sherriff will teach this course and indicates this is her area of expertise. A detailed syllabus is included with all of the appropriate SLOs, program outcomes, course prep, course requirements, etc.

Action: Recommend Approval (Chris)

12–061: HSU New Course Proposal

A new course, GEOG 356M (1 unit, C4), is proposed as a Depth Experience, discussion section that is a co-requisite to the new course, GEOG 356 (see 12-060). This course will provide in depth discussion and exploration for data collection methodologies that will be critical for successful completion of GEOG 356.

Action: Recommend Approval (Chris)

12-062: HSU New Course Proposal

A new course, GEOG 357: Climate, Ecosystems, and People (3 units, C2), is proposed as an additional option for Geography majors. Addition of this course does not change the program (i.e. no additional units are required). The content of this course has been taught previously as a special topics course (GEOG 473) and was well received by students in the Geography Department as well as others. The course will be offered once every other year; however, there is no indication if this will be Fall or Spring or if this will be taught in the same cycle as the new course, GEOG 356 (see 12-060). Presumably it will be offered during the off sequence as GEOG 356 as both of these courses will have the same instructor. The course perquisite is GEOG 106 and the course is intended for junior/senior standing Geography students. There will be an academic restriction for freshman and sophomore standing students. Rosemary Sherriff will teach this course and indicates this is her area of expertise. A detailed syllabus is included with all of the appropriate SLOs, program outcomes, course prep, course requirements, etc.

Action: Recommend Approval (Chris)

12-063: HSU New Course Proposal

A new course, GEOG 357M (1 unit, C4), is proposed as a Depth Experience, discussion section that is a co-requisite to the new course, GEOG 357 (see 12-062). This course will provide in depth discussion for topics covered in GEOG 357.

Action: Recommend Approval (Chris)

12-081: HSU New Course Proposal

The Wildlife Conclave, Wildlife National Student Competition, is proposed as a new course as preparation for student competitions in wildlife management and conservation. Currently, this course is offered as a special topics (WLDF 480) and has ample enrolment (+30); however, the Wildlife Department wishes to make this a unique course. Due to the unit-cap and the unique and time-consuming aspect of teaching this course (coach/mentor) it will be 1 unit of C78 (1 SCU, 3 WTU). Addition of this course does not change the program requirements and no new impacts are anticipated. There are no pre-requisites. Additionally, the HSU Wildlife Conclave team as won 8 of the past 11 national competitions.

12-092 English Graduate Program emphasis in Literature 12-093 English Graduate Program emphasis in Teaching of Writing

The English graduate program is being updated for the first time in twenty years to reflect the current state of the discipline, to increase its marketability to prospective students, to increase the student's marketability to potential employers or PH.D. programs and to increase the efficiency of the program for students.

The proposal, approved by the college dean, increases the number of units from 32 to 40. However, in the common case where the students would like to teach English 100 basic composition, the revised program will lower the number of units for students in the literary option track. In either emphasis 45 units are required if the student wishes to be qualified to teach English 100.

11-222 EMP 309 Environmental Conflict Resolution course change and associated proposals

11-256 ENVS 309 Environmental Conflict Resolution (cross listed as EMP 309)

12-083 Environmental ethics minor program change (course numbering)

Remove EMP 309/ENVS 309 from UD GE Areas B and C. The CWT (Communication and Ways of Thinking) designation should also be removed and the course listed under UD GE Area D. The reason for this change is that the course does not meet the learning outcomes for UD GE area B or C. The course numbers will change from EMP 309/ENVS 309 to EMP 305/ENVS 305 to avoid confusion with 309 numbered CWT courses.

Forestry program change form is part of package of forestry changes

12-088 Liberal Studies Child Development program change

Adds two classes as alternatives in the core curriculum. This change will give students more options to complete the major, aid students who have an interest in working with American Indian families and help students complete a minor in American Indian Education.

AIE 330 History of American Indian Education is added as an alternative to CD 310 Perspectives: History and Theory AIE 335 Social and Cultural Considerations is added as an alternative to CD 467 Working with Culturally Diverse Families.

12-008 Environmental Science BS Ecological Restoration Option Program Change

Changes the catalog to explicitly state the desire course selection for the Ecological Restoration Option.

BOT 330 (Plant Ecology) and FISH 320 (Limnology) are both listed as options for the Ecological Restoration option. It has always been the department's intention to require the labs associated with these classes. However, since the labs are listed separately for the main course section, the catalog should separately and explicitly include the lab requirement. BOT 330 plus BOT 330L is three units which is same number of units as are other alternatives and the number of units list in the MAP.

FISH 320 plus FISH 320L is four units. The 9 alternatives to this course are all 3 units and so students can and likely will take a three unit option which will keep the number of units required for the degree unchanged.

- **12-007 BA 482 Internships** Change grade mode from C/NC to letter grade. Change repeat limit to 2. Letter grade designed to motivate students to perform better in course. Repeat limit necessary so student can do two different kinds of experience (tax prep and business skills). *[Recommendation: Approve; Shepherd: Abell]*
- **12-133 MBA Strategic Sustainability** Program Change adds one course BA 682 Business Administration Internship (see below) to provide practical business work experience. Program currently lacks such an internship. Feels addition of course will strengthen hands on learning aspects of program. Increase in units for degree from 34 to 36. *[Recommendation: Approve; Shepherd: Abell]*
- **12-134 MBA 682 Business Internship** New course proposal. 2 unit internship: supervised experience in business, governmental or service agency. Course will strengthen hands-on component of MBA. Instructor support provided through business department's share of Chancellor's fee for graduate professional degree. *[Recommendation: Approve; Shepherd: Abell]*
- **12-135 MBA 692 Master's Degree Project** Unit change from 1-3 to 1. Change repeat limit to 3. Department wants to split what can be a 3 unit course in one semester into repeatable 1 unit course for 3 semesters. Should facilitate student progress through Master's Project and make it more manageable for faculty to advise. C-classification will also change from S-3 (S25) to C-78 reducing WTUS per student by roughly half (i.e. from 0.5 per student for 3 credits to 0.083/unit/3 semesters for 0.25 per student). *[Recommendation: Approve; Shepherd: Abell; Discussion Item for ICC: Are Master's / Thesis Project courses held to same standards/requirements as undergraduate independent academic work courses? (e.g. stipulating the number of hours of instructor interaction, stipulating equivalency between credit units and student workload, etc...)*
- 11-503 GEOL 335 Geology Field Methods II. Replace "GEOL 332 (C)" in current list or pre-reqs to "GEOL 312 or GEOL 332 (C)". Current list of pre-reqs is GEOL 108 or GEOL 109, GEOL 235, GEOL 332 (C), IA. Students need to be able to describe rocks if they take GEOL 335 and GEOL 312 (Earth Materials) offers another course in addition to GEOL 332 to provide this instruction. Original proposal was questioned because it seemed appropriate to let GEOL 312 also be a co-req, but the department specifically requested it not be. GEOL 312 is already in the upper division core of the major so it will not increase units to degree. It will offer students more flexibility to meet the pre-reqs. Geology minors may also gain some flexibility in meeting pre-reqs. They have to choose between either GEOL 312 or GEOL 332. Addition of GEOL 312 opens up GEOL 335 to minors who want to incorporate it into their elective. *[Recommend: Approve Shepherd: Abell]*

12-160 SW 420: Decolonizing Social Work with Indigenous Communities (New Course)

1/5 units, can be taken for a total of 3 times. This course has been offered as a special topics course (summer 2012). Description: "Prepares students to understand and support Indigenousness and Sovereignty (Self-Determination). Promotes awareness of colonization and decolonization processes affecting Indigenous Peoples and how social workers can participate in solutions affecting them." Course not required for any programs. This course offers students an HSU-affiliated class that meets prerequisites for certain graduate SW programs, including HSU's. It will be online only and offered through self-support. Several faculty in department qualified to instruct this course.

Recommend approve/Jodie

12-139 SPANISH PROGRAM CHANGE

Reduce the Spanish capstone course from 4 units to 3 units and move the extra unit into electives

12-143 SPAN 492 Senior Project COURSE CHANGE

Reduce the capstone course from 4 units to 3 units and change the course from C-5 for 1 unit and the rest in S-36 (.33 per student) to 3 units of C-5. C classification change is being done at the Dean's request to standardize the workloads.

RCOMMENDATION: Approve both (Anne)

12-142 SPAN 315S Intro: Translation & Interpret NEW COURSE PROPOSAL

Course is C-4 for 3 units and repeatable for credit two times. Students must meet the prerequisite of native or near native Spanish proficiency; 5 semesters of college-level Spanish or equivalent; or instructor approval. The course has been offered previously as a 480. The description reads "Apply theoretical and practical principles of translation and interpretation of literature, real-world texts, and oral contexts. Analyze social/cultural implications of working in this field. Practical experience through service learning." It will meet UDGE Area C and Domestic DCG. The department says no additional resources are required as there are available personnel to teach the course. The Service Learning Paperwork lists 20 hours of supervised time and 45 hours of partial supervision under workload for both student and professor. The committee is unclear how this is covered by the present classification. The department has not responded. The committee also noted that the department should choose a 30x number for UD GE designation. The department has not responded.

RECOMMENDATION: The Committee would like to know whether the ICC would like to provide provisional approval and move this forward while we wait for departmental response or whether the ICC would like to hold this for next catalog year so that the issues can be cleared up.

Rosamel,

We are in our final push at the CDC to get things ready for the last meeting of the ICC this coming Tuesday and I noticed a couple of problems with this proposal.

First, generally course wich are upper different problems.

You are proposing a number that is not in that sequence.

Additionally, the course is listed as 3 units yet the service learnign component is listed as 65 hours for both the student and the professor. The math does not work. Twenty of the student hours are to be supervised which suggest some form of C or S class for that. Please let me know how you wish to proceed. I need to know right away if there is any chance to get this in the next catalog cycle.

Well this is what we need to discuss over the phone as we maybe dealing with a conceptual question about service learning related hours more than anything. This is mainly related to translation and interpretation assignment students need to complete in the course of the semester. The 65 hours are broken into 20 supervised hours and 45 independent hours.

The supervised hours can be also understood as in class supervision as we use the assignments (These are real community

translation and interpretation assignments) as in-class teaching context. In addition, when possible, we invite people from the organizations to meet with us to discuss their documents and provide vital information for the students. Finally, we do have a field component where we go to the organizations to meet them and do field interpretation. All this is supervised direct work and we estimated 20 hours.

The non-supervised 45 hours, indirect service learning work, is related to the time the students work independently in each translations and interpretation assignment. As these assignments are done for real and to serve real community organizations the students are indeed doing service learning work.

So, this is the background to the 65 hours listed in the "S" document. I hope this helps,

Nutshell: CCTC (CA Comm. on Teacher Credentialing) provided recommendations to address subject matter competency, and dept. has reconfigured concentration to address CCTC's pedagogical standards. Four 2-unit courses (KINS 317/319/321/323) have been restructured as two 3-unit courses and one 2-unit course; major units remain unchanged. **These new courses (KINS 325, 327, 329) were approved by the University Senate on 12-14-11;** this program change clarifies the intent/scope of these approved courses.

10-386 PSYC MA: Counseling

Program change overview:

The department is requesting changes because of new opportunities for licensure in California for mental health therapists. Previously, California had only one masters level of license for mental health therapists, the Marriage and Family Therapist (MFT) license through the CA Board of Behavioral Sciences (BBS). Beginning in 2012, the BBS has introduced a new license for mental health practitioners, the Licensed Professional Clinical Counselor (LPCC). These two licenses will have somewhat different scopes of practice, with the MFT focusing more on underserved and seriously mentally ill couples and family populations, and the LPCC focusing more on general mental health practice and mental wellness.

This program currently meets the BBS requirements for masters education toward licensure for an MFT, with the changes here, students will also be eligible to be licensed as LPCC.

Removing from requirements:

PSYC 545 "Psyc Testing" This course is not necessary for MA: Counseling because content covered in PSYC 672; it is not being suspended from the catalog because it is utilized in PSYC undergrad program. -4 units

PSYC 646 "Personality Assessment" This course is not necessary for MA: Counseling, but not suspending it from the catalog because it is one in a "choose from" list in PSYC BA program capstone experience area. -3 units

Adding to requirements:

10-490 PSYC 664 "Assessment and Testing for Psychotherapists" New course (3 units) which has been offered as a topic of PSYC 680. Description: Overview of formal psychological testing and assessment, especially practical applications including types of information gathered; understanding client psychological assessment reports; and administering tests within the boundaries of competence. +3

10-487 PSYC 673 "Mental Health Addiction and Recovery" New course (1 unit) which has been offered as a topic of PYSC 680. Description: Overview of drug abuse, covering commonalities and differences among drug classes, neural systems involved, addiction processes, treatment and recovery, and social-cultural dimensions. +1

Changes to required courses:

10-492 PSYC 660 increase units (from 2 to 3 units) extra unit comes directly from unit removed from PSYC 662 and the content. Requirements for LPCC licensure include 3 units of law and ethics. +1

10-488 PSYC 672 "Advanced Psychopharmacology" title change to "Psychopharmacology", increase units (from 2 to 3 units); Additional content to include: factors influencing drug abuse, including drug pharmacology, individual risk factors, and therapeutic strategies. +1

10-489 PSYC 662 decrease units (from 2 to 1 unit), moving some content to PSYC 660, Law and Ethics in Psychology, to meet new requirements for licensure for counseling masters students. -1

10-491 PSYC 653title change, from "Psychotherapy with Children and Families" to "Advanced Psychotherapy with Children and Families" (will be abbreviated in PeopleSoft). The new title better reflects that the course follows PSYC 654 ("Interviewing and Counseling Techniques". No additional changes to this course. No change to units.

11-461: RS 304: Cultural, Religious Heritage Africa - new course proposal – GE Area C

11-462: ES 307: Multicultural History - Africa - new course proposal – GE Area D

11-468: FREN 324: Introduction to Language OR Intensive French Language: Regional Studies, change C-class and units from 3 units C-78 to 1-4 units C-5.

11-469: FREN 326: Culture and Civilization: Regional Studies, change C-class and units from 3 units C-78 to 1-4 units C-5.

11-497: Senegal Program proposal

These are courses for a new summer program to be taught in Senegal. The GE Courses are approved exclusively for use in Senegal because the total immersion in the culture is needed for students to be able to meet the Federal Standards for hours of work associated with the credit hour.

This program will also need to be approved by the International Program Review Committee; the hope is to begin this program in the Summer of 2014.

Our current International Studies program is an option under Interdisciplinary Studies. AMP fully supports changing this to a stand-alone Major in International Studies. [Recommend Approve]

Process: When AMP and the ICC approve this initial request, HSU then asks the Chancellor's office for permission to add a stand-alone International Studies major to HSU's Academic Master Plan. Once the program is added to the Master Plan, they can begin work on the formal proposal for a new Major. We will report today's results to the University Senate as an information item. When we get to the full application for a new Major, then University senate must approve the proposal before it is sent to the Chancellor's Office.

Note: Given our current fiscal climate, it is very possible that the Chancellor's Office will not approve any additions to Academic Master Plans this year.

Presently students take BIOL 330 or WLDF 301 as one set of choices and FOR 231 or BOT 330/L or RRS 370 for the other choice. All these courses will now be combined into one list and students will choose one option. *Note: This proposal also includes a great many non-GSP changes. This same proposal will also appear in the descriptions for the Environmental Science program changes.*
