# 1. AMP: English Stretch Program

### 10-470: English Stretch Program

This is a new approach to the English Composition requirement. Students will use directed self-placement to determine whether to take ENGL 104, a one-semester version of the Freshman composition and rhetoric course, or a two-semester sequence of ENGL 102 and 103 which stretches the same course material over two semesters. Students who need further assistance with writing will be encouraged to consider taking ENGL 215: Information Literacy and Writers Seminar. Directed self-placement is in use at many Universities across the country; research indicates that students generally DO place themselves in the right course. The English department has prepared self-placement guides (which are included as part of this proposal).

The existing English 100 courses will be deleted and replaced by these new courses.
