**09-069: SPED 756: Advanced Studies: Mental Retardation** Change course # to SPED 656 to indicate that this is graduate-level work. (700-level courses are “credential” and not “graduate.”)

**09-279: Communications Program Changes** Clarifies catalog text to reflect the department's intent for majors. COMM 110/310 (1-3 units) "Intercollegiate Speech and Debate" may be used to fulfill the Public Communication Skills requirement in the major, and may also be used as major electives. This change would clarify catalog text (and a MAP footnote) to say that "no more than 3 units" of 110/310 may be used for the Public Comm requirement, and that "a total of no more than four units may be used to meet major requirements." Also clarifies in the catalog that, to fulfill the Special Topics requirement, COMM 480 (1-4 units) "Seminar in Speech Communication" must be "taken from a single 3 or 4 unit class."

**6. AMP –**

We recommend approving the new Interdisciplinary Studies – Critical Race, Gender, and Sexuality Studies Major. This is a revision/combination of the existing IS options in Ethnic Studies and Women’s Studies plus the elevation of the Multicultural Queer studies minor to an pathway within the new IS-CRGS major. In addition, AMP would like to encourage encourages CRGS to begin the paperwork for becoming a

“stand-alone” (not Interdisciplinary Studies) major as soon as CRGS has established sufficiently high enrollments to justify the application for a new Major.

*Summary of Issues considered in making this Recommendation:*

*1. The Name: Will students be attracted to Critical Race, Gender, and Sexuality Studies rather than the more specific Women’s Studies, Ethnic Studies, etc.? Answers: The Discipline is moving in the direction of a more combined approach, so this name reflects current trends. We will retain course prefixes of WS and ES, as well as catalog cross-references that direct students interested in those subjects to the IS-CRGS Major.*

*Finally, all the CRGS fields are ones that students most typically discover after taking a GE class in the discipline, so the question of “will high school students know what CRGS is” is mostly not relevant.*

*2. Given the relatively small numbers of graduates from Ethnic Studies, will the CRGS be able to reach the needed enrollment to permit the classes in the Pathways to be offered? Based on course enrollments during past several years, there should be no problem. Students from various majors take these courses, so they have much healthier enrollments than the number of majors would suggest.*
