**09-238 NRPI 460** – course title and description change; from Natural Resource Agency Planning to Environmental Planning for Public Lands - New Description: Environmental planning processes applied by state and federal agencies to manage for desired ecological, economic, and social outcomes on public lands. Key themes: collaborative processes, community involvement, stewardship. Request makes no substantive changes to course content, but modernizes course title and description.  
Recommend approve.

#### **09-241 ZOOL 476** – Principles of Animal Development

Change from 2-unit lecture & 2-unit lab to 3-unit lecture & 1-unit lab. Course description change: Developments in field (increased emphasis on understanding genes and cellular and molecular biology) require increased lecture component in order to adequately address topics that can't be covered in lab. Change will also better support students entering field of stem cell research. Reducing lab to 1-unit will still provide lab experience for students. Requested change is based on *evolution* of the field and is mechanism to better serve student population entering field of stem cell biology. Change also reduces WTU by 1 unit.  
Recommend approve.
