<p>facilitators are centrally trained in SI techniques. (We also recommend that student facilitators would still consult frequently with faculty teaching the course about specific SI exercises/lesson plans.) As part of the transition to only offering SI classes through the Learning Center, we also recommend that SI courses cease to be offered for credit.</p> <p><i>Rationale: Eliminating credit for SI classes will allow students to benefit from SI without accumulating additional expensive units.
